#### **BUDGET AMENDMENT:**

A motion by Frank D. Wasylewski and seconded by Cindi Lambdin to amend the budget for fiscal year 2020-2021 with projected revenues of \$188,574 and projected expenses of \$165,385; a projected Road Fund balance of \$492,147.20 and a projected Fire Debt Fund of \$17,876.32 effective 31 March 2021. All in favor, motion carried.

A motion by Frank D. Wasylewski, seconded by Cindi Lambdin to appoint Marlene Guerin, Victor Malkowicz and Frank Wasylewski to a 2-year term as Hudson Township Board of Review members. All in favor, motion carried.

Saturday 1 May 2021 is the date for the Township Spring Clean Up.

A discussion was had regarding which road/roads the Township will be improving this year. Will discuss more at the next meeting.

#### Fire Department:

- The Clea license renewal is due 2 April 2021. The cost is \$180.00.
- There is a need to purchase 2 new AED'S. One for fire and rescue and one for the hall. The cost is \$1500 per defibrillator plus batteries and pads. The board agreed to the purchase.
- John Knott and Brice Holland both completed the Medical first responder training and will be taking the exam for the state license soon.
- Fire Chief Lon is working on grands for new doors for the fire hall.
- The fire Department offered to help the Township with the costs of a new Township Hall sign.
