- Charlevoix County has foreclosed on the gas company property located on Camp Ten Road, which is still delinquent for taxes to the township. The next step is for the Township Treasurer to seize and sell the personal property located on the land.

New Business:

- Received bids from the Charlevoix Road Commission for a paving project on Woodward Road. A motion by Frank D. Wasylewski to accept the bid of \$406,982.00 submitted by Rieth-Riley Construction for the Woodward Road Paving Project from Camp Ten Rd. North to Bows Lake Rd. (1.41 miles), seconded by Cindi Lambdin.
