Meeting called to order by the Supervisor, Terry Erber at 7:00pm in the Township Hall.

A motion by Frank D. Wasylewski to accept the 6 July 2022 regular meeting minutes as presented, seconded by Terry Erber. All in favor, motion carried.

A motion by Cindi Lambdin to accept the Treasurer's report as presented; seconded by Caroline Kobylczak. All in favor, motion carried.

Old Business: A public meeting was held on 12 July 2022 to discuss a solution to the numbering issue on North Camp Ten Road. Emily Selph from the Charlevoix County Equalization Department was in attendance. Several residents attended to ask questions and voice opinions regarding the issue. The majority consensus is to re-name North Camp Ten Road to Camp Ten Road and change the road numbering from north/south to east/west.

RESOLUTION:

WHEREAS, the range of house numbers assigned to North Camp Road in Hudson Township are the same range assigned by Otsego County to Camp Ten Road, all with an Elmira address, making emergency response, deliveries and mail very confusing, and

WHEREAS, 911 emergency calls have been sent to the wrong dispatch center, causing delay in emergency services, and

WHEREAS, changing the road name to "North" Camp Ten Road did not correct the issue, and

WHEREAS, Hudson Township, has been seeking a solution to this problem for decades.

NOWTHEREFORE, BE IT RESOLVED, Hudson Township, Charlevoix County requests the Charlevoix County Department of Equalization, change the current north/south range of North Camp Ten Road to an east/west direction, allowing the reassignment of house numbers consecutively with Otsego County, and

BE IT RESOLVED, Hudson Township recommends Charlevoix County Equalization approve the private road names of Koby Drive and Swamp Crossing Drive in Section 29, and

BE IT RESOLVED, Hudson Township requests Charlevoix County Road Commission approve recommended name change of North Camp Ten Road to its original name of "Camp Ten Road".
